- 1. Fall fundraising discussion
 - a. Halloween themed trivia scheduled for Oct. 24th. We'll charge this time around with individual and group pricing. Amy suggested getting a sandwich board sign up at the family flu clinic the weekend of Oct. 17th. Fundraising for the library technology fund for this event. Funds would be used to augment or fund technology-related items to bring to the new library or any quick technology needs during Covid.
 - b. Aimee looking into creating a virtual marketplace in place of 2021 Arts and Crafts Fair. Vendors would pay to be part of the online marketplace and FOTSL would promote it. Thought is that we could attract outside vendors.
